I Acceptance of Terms

These Terms of Use ("Terms") constitute a legally binding agreement between you and YourCourts, Inc. ("YourCourts," "we," "our," or "us"), a company co-owned by Three Meadow LLC. By accessing or using any part of the YourCourts

platform — including yourcourts.com and any associated applications — you confirm that you have read, understood, and agree to these Terms.

If you are accessing YourCourts on behalf of a club, homeowner association, university, park, or other organization, you represent that you have authority to bind that organization to these Terms.

If you are a member or user belonging to one of these organizations, you are bound by both that organization's rules and policies and these Terms.

2 Intellectual Property

All content, software, designs, text, graphics, logos, and other materials available through YourCourts (collectively, "Materials") are the copyrighted property of YourCourts, Inc. and Three Meadow LLC. All rights are reserved.

3 Permitted Use

4 Prohibited Conduct
